VICTORY ANNOUNCES DEBT SETTLEMENTS

VANCOUVER, BC, CANADA (March 28, 2024) – Victory Battery Metals Corp. (CSE: VR) (FWB: VR6) (OTC: VRCFF) ("**Victory**" or the "**Company**") announces today that it has closed its previously announced shares for debt settlement transaction. The Company entered into settlement agreements that settled \$463,025 of debt by the issuance of 9,260,500 shares at a deemed price of \$0.05, and the Company's balance sheet much improved.

No finders fees were paid. The securities issued will be subject to a four-month and one-day hold period from closing.

Certain insiders participated in respect to accrued and unpaid fees and expenses. The Company is relying on exemptions contained in NI 61-101 from minority approval and valuation requirements for related party transactions.
